Times: Saturday 10:00 am to 5:00 pm, and Sunday 10:00 am – 4:00 pm

Vendor Set Up: Friday, beginning at 11:00am

Please note the following rules and requirements: Vendor will assume responsibility for all set up or installation, take down, and removal of their merchandise. Breakdown and clean-up begin after the raffle at 3:00 pm on Sunday, and must be completely finished by 6:00 pm, except for those staying overnight. Vendors are responsible for all clean up and for any damage to their space. No vendor may assign or sublet any space without permission of VGMS. Merchandise offered for sale to the public must be correctly represented and labeled. It is the vendor's obligation to comply with all state and local laws and regulations. VGMS and/or AGSEM will not be held liable for losses due to fire, theft, natural disasters, breakage or damage of any kind. Vendor assumes responsibility for obtaining independent insurance.

- Location is DRY CAMPING ONLY. Water and restrooms are available on site. No tables or chairs will be provided.
- Pets must be on a leash on museum grounds. No open fires are permitted. No alcoholic beverages are permitted during show hours.
- This is an OUTDOOR SHOW, rain or shine. There are NO INDOOR SPACES.
- Museum gates are locked between 6:00 pm and at 10:00 am, and the museum is closed on Mondays. There is no re-entry to the museum grounds during those times.

Reservations are required. Booth spaces will be assigned on a first-come, first-served basis.

Booth space sizes: single 20x20 feet, double: 20x40 feet, with approximately 6 feet between.

FEES ARE: \$200 PER SPACE, \$400 FOR DOUBLE

All vendors are asked to provide a raffle item for each space by early Friday morning.

Vendor fees will be refunded only in the event show is cancelled due to circumstances beyond our control.

Bounced checks will be charged a \$35.00 fee.
