Please note the following rules and requirements: Vendor will assume responsibility for all set up or installation, take down, and removal of their merchandise. No vendor may assign or sublet any space without permission of VGMS. Merchandise offered for sale to the public must be correctly represented and labeled. It is the vendor's obligation to comply with all state and local laws and regulations. VGMS and/or AGSEM will not be held liable for losses due to fire, theft, natural disasters, breakage or damage of any kind. Vendor assumes responsibility for obtaining independent insurance.

- Single day vendors may start setting up at 8am on Saturday, and must be ready by 10am when the show opens.
- Pack-up begins after the show closes at 5pm. Vendors must complete all clean-up and exit the grounds by 7pm.
- Water and restrooms are located on site. NO tables or chairs will be provided.
- Pets must be on a leash on museum grounds.
- This is an OUTDOOR SHOW, rain or shine. There are NO INDOOR SPACES.
- No alcoholic beverages are permitted.

Reservations are required. Spaces will be assigned on a first-come, first-served basis.

Booth spaces are approximately 10x10 feet.

FEES ARE: \$100.00 PER SPACE.

All vendors are asked to provide a raffle item.

Vendor fees will be refunded only in the event show is cancelled due to circumstances beyond our control.

Bounced checks will be charged a \$35.00 fee.
