Please note the following rules and requirements: Vendor will assume responsibility for all set up or installation, take down, and removal of their merchandise. No vendor may assign or sublet any space without the approval of VGMS. Merchandise offered for sale to the public must be correctly represented and labeled. It is the vendor's obligation to comply with all state and local laws and regulations. VGMS and/or AGSEM will not be held liable for losses due to fire, theft, natural disasters, breakage or damage of any kind. Vendor assumes responsibility for obtaining independent insurance.

- Single day vendors may start setting up at 8:00am on Saturday, and must be ready by 10:00am when the show opens. Pickup begins after the show closes at 5:00pm. Vendors must complete all clean-up and exit the grounds by 7:00pm.
- Water and restrooms are available on site. No tables or chairs will be provided.
- Pets must be on a leash on museum grounds. No open fires, generators, or alcoholic beverages are permitted.
- This is an OUTDOOR SHOW, rain or shine. There are NO INDOOR SPACES.

**Reservations are required. Booth spaces will be assigned upon vendor arrival.
Spaces are approximately 10x10 feet**

FEES ARE: \$100 PER SPACE

All vendors are asked to provide a raffle item.

Vendor fees will be refunded only in the event the show is cancelled due to circumstances beyond our control.
Bounced checks will be charged a \$35.00 fee.
